## MCPS NASS Collecting 506 Forms

MCPS Native American Student Services is currently collecting 506 Forms. One of the NASS Specialists might be contact you if we are missing the form for your child.

### **What is a 506 Form?**

The 506 Form is formally called the 'ED 506 Form: Indian Student Eligibility Certification Form for Title VI Indian Education Formula Grant Program.' The form is an official record of eligibility for Native American children to be included in the Native American student count for Missoula County Public Schools.

### **Is the 506 Form required?**

You are not required to submit a form. When you choose to complete a form for your student they are counted for funding through the Title VI Indian Education Formula Grant. Without the completed form we are not able to include your child in the official Native American student count for Missoula County Public Schools.

### **How does the 506 Form impact my student?**

MCPS NASS capacity and programming is determined each year in part by the official Native American student count.

Funding through the Title VI Indian Education Formula Grant Program pays for programming to provide academic and cultural support for Native American students.

### **My child isn't an enrolled tribal member. Can I still submit the form?**

Yes! The 506 Form can be completed using the tribal enrollment number of the student's parent or grandparent. If your child is not an enrolled tribal member or a 1st or 2nd degree descendent they are not eligible to be counted in the official Native American student count for the Title VI Indian Education Grant. However, they will still be welcomed and supported by the MCPS Native American Student Services team!

- Members serve 2 year terms
- Nomination Deadline: September 29, 2023
- PAC Election: October 4, 2023


