I know that is not what govenor Bullock nor the health department has said, but not everyone listens to their regular updates and actions speak louder than words. I provide mental health support to people in our community, some of whom are essential workers, some of whom are teachers, and what I hear from them is that they are scared. They recognize that they are putting their health and well being in the hands of the community whom they serve and they do not trust that some people are currently taking adequate precautions and fear what is going to happen when we open things up further. Additionally I am greatly concerned for the well being of my children, my child clients and their families and the staff of MCPS. A tremendous amount has been asked of staff in the last month and a half and they have risen to the significant challenge. To ask them to change what has just begun to work and to add in the additional intensive measures that will be required to keep everyone safe is too much in what will ultimately be such a short period of time. A few weeks of in person instruction is not worth the risk to families. I understand that this pandemic is not over and that it is to be expected that many more people will become infected. That the purpose of shelter at home was not to entirely prevent this, but to flatten the curve so that our medical facilities did not become overwhelmed, but I also feel that Missoula was and will continue to find ways to make things work, for everybody, for as long as it takes, because we believe every life is worthwhile. I beliece we should be focusing on helping our businesses find
-	Until we have the ability for anyone who wants a test to get one, we should not be lifting restrictions, especially in places where people gather like churches, schools, and parks. Keep schools closed. Requires any business's that open to use and provide masks. It's too soon.
	I think it is dangerous and irresponsible to begin reopening Missoula businesses and schools so soon. Distancing is still vital and to do so will put countless Missoula residents at risk. The promising numbers we are seeing are only because of these distancing measures, and to lift them too soon will reverse all of our progress and lead to a shutdown that will ultimately be longer and more damaging in the long term. As a service industry worker, as much as I would love to be back at work, I don't feel comfortable returning to my workplace and putting myself and others at risk. I strongly urge Missoula County government to extend the closures of restaurants, bars, and schools. The reopening of businesses and schools could be detrimental to the health of our residents. If we reopen and our cases spike, we could have to start this process all over again. Businesses may not be able to bounce back from this twice.

Following state recommendations for opening businesses, bars, and schools will put your constituents in danger. People will be forced to decide: should I (1) go back to work in unsafe conditions where I am not supplied with adequate PPE by my boss because it is not required by my state or local government, or do I (2) lose my job, lose access to CARES Act relief, and also become ineligible unemployment. THIS IS NEGLIGENCE. You are (once again) stating that the economy - aka profit for business owner's on the Governor's advisory council, such as Nick Checota - is more important than the lives and safety of everyday people.

I am a business owner. I am concerned about other owners not adhering to increased health and safety practices to protect the public. I am concerned about other employers requiring their employees to return to work even if they have high risk family members at home to protect. What job protection should they have? This does directly effect my business and my family. I have 2 high risk members of family that live with me. With the increased contact rate, how can we better protect the members of our high risk community? If we opened much slower, with wait times between to see rate of increase, I would be behind it. If there was protection for employees that shouldn't be going to work, then I would support more opening. My suggested solution would be that businesses must submit a plan of action in order to open. This plan should address the concerns previously mentioned, plus how they will enforce social distancing. If plan is approved, then they can open. I feel this is fair. On one other note, I feel that it would be very irresponsible to open our large school districts at this point. They would only be in school for 5 weeks. The transition back alone would be difficult for our children. The health risks and rate of transmission into households worry me. Finally, expecting teachers to accommodate for BOTH in class and distant learning would be an impossible ask. I do believe that we should start to reopen our state, i just feel that we must be prudent in the way it is done. Thank you for your time.

	I believe that schools should continue doing remote learning for the remainder of the 2019/2020 school year. I work in healthcare at a local hospital and feel that reopening schools, restaurants, etc. too early is putting our most vulnerable Montanans at risk. While I do agree that the reopening of businesses and other things should be done in phases, I feel it is too early to begin that process. The health and safety of all Montana residents should be the top concern, as there is nothing more valuable than human life.

	We would like to see a more cautious plan with more widespread public testing, an extended stay at home period, extended closures, and no school opening this season.
	My husband is a research scientist, working in part on COVID-19 vaccine formulation. We believe science and safety should dictate for the long-term benefit to our community. It is far from over. The shelter in place has not lifted yet and people are already ignoring those orders. If we open too soon we risk spreading at a faster rate. I know of several people with signs of covid who have not been tested and told to return home. We all want our friends to go back to work but opening now seems like a waste of our efforts. Schools especially should remain distant learning.

It's important that science guides decisions made when it comes to the response to the COVID-19 pandemic. The Stay at Home directive is proof that implementing early aggressive actions to ensure the safety of our community works.

Based on the information we have about the virus, it is imperative that we not let the safety of our community be influenced by the bullying of those myopically focused on selfish reasoning. Also, we need to seriously consider the impact of decisions on those most vulnerable - how will we ensure companies take the necessary steps to protect their employees when business is reopened? Please do not allow the re-opening of bars, restaurants, tattoo shops, salons, daycare centers, and other places where the employees will be put at risk from close, prolonged contact with multiple customers until there is adequate testing, resources for contact tracing, and other science-based methods of limiting the spread of Covid 19. Prematurely allowing these places to go back into business is just a recipe for disaster, rendering pointless all the economic and personal sacrifices we have already made over the last weeks. Missoula County does not have adequate testing capabilities to ensure public safety if people begin mingling in enclosed spaces again, nor the hospital capacity to care for all the people who will require care during the inevitable outbreak. Service industry workers are disproportionally represented among low-income workers and will be forced to choose between their lives and their livelihood, while their employers get to take advantage of tax breaks, and other bailouts from the safety of their living rooms. If the Health Dept says these places can open again and the employees refuse to put their lives and their family's lives at risk, they can be fired and will not be eligible for unemployment. My family is trying desperately to protect my husband, who will very likely die if he's infected with the coronavirus. He is immunocompromised and has severely reduced lung function due to an ongoing, 7 year-long battle with metastasized bone cancer. In the absence of reliable, effective treatments for Covid-19, we cannot risk bringing the coronavirus into our home, so aside from total self-isolation for the past 6 weeks, we must now rely on the decisions of others to protect him.

My sons are local high school students. It is my sincere hope that the Missoula County Health Department advises MCPS school board to make the safe & prudent choice NOT to reopen schools for the remaining 6 weeks of this academic year. I believe the choice to bring students back together in classrooms, crowded hallways & shared bathrooms puts our entire community at grave risk. Should schools reopen, my 2 students will not be able to return to class and will have to continue remote learning (also missing any in-person graduation ceremony).

We also desperately need a city-wide campaign, which STRONGLY encourages or mandates the public to wear masks to protect the vulnerable. People are confused, thinking that they should only wear a mask if they're sick, or not personally at risk. I'm so disappointed by what I see every day as I've worked from my kitchen table for the past 6 weeks. No one walking or riding their bikes is wearing any kind of face covering. As businesses begin to re-open, there will be community spread, especially if masks aren't used and these choices could lead to more illness and death.

Thank you for considering my comments and for making the safety of our community your top priority. We can't be "all in this together" unless we are willing to make sacrifices to 24-Apr protect the lives of those most vulnerable.

Remember 1918. Re-opening too soon will result in a second wave. More people will die. Re-opening now is a short-sighted solution to a bigger problem. It will be BETTER for the economy long term to remain closed and re-open when there is widespread testing for ALL residents, not just those who are symptomatic. Please remain closed. *ESPECIALLY* the 24-Apr schools.

First, many thanks for the thoughtful and deliberate actions that have helped to keep Missoulians safer.

My hope as a citizen is that Missoula is slow to reopen business as usual. I hope that people are not forced to go back to work front line jobs at the peril of their families' health. I hope that kids are not sent back to schools, where this virus could take up a swift and unforgiving front. I hope that creative solutions like neighborhood internet hot spots, neighborhood organizing efforts, and fierce advocacy from our elected officials to extend lifeline relief efforts like the increase to SNAP benefits and unemployment be the first and most aggressively pursued priorities.

I also hope that decisions are made with everyday people at the table. Any decision-making body regarding the reopening of Missoula should have citizen representation equal to the representation of C-suite business representatives and elected officials.

I do not think the schools or high traffic businesses should be opening up. We will see an increase in cases of Covid-19. Please support the social services continuing to work and 24-Apr support vulnerable populations at this time.

I would like schools to remain closed until next fall. The online instruction seems to be working OK and the risk of having students return for less than a month does not seem a wise 24-Apr choice, in my opinion.

In the last couple of days I have been making phone calls to people who use and volunteer at the Food Bank. The purpose was to determine how the pandemic has been affecting that population, many of whom have been hard hit. The governor's announcement about phased reopening came while I was making calls, and several people responded with concern that this was premature--especially for schools and for bars and other gathering places that serve alcohol. They felt that it was unrealistic and unsafe to reopen schools and those establishments. (Apparently many schools have already decided not to reopen.) I share those concerns. I read the details published in the Missoulian, and think it is quite unrealistic to think people in bars, breweries, etc., will be able to observe social distancing or will wear masks. What good does it do to limit the number of people at a table if one of them is a carrier without symptoms? How does the proprietor determine what 50% of usual numbers is? I truly sympathize with the owners of these establishments, but we are still seeing more covid-19 cases in the state. Please let us not rush into this reopening because of 24-Apr our isolation and frustration. More cases, more deaths would be far worse. We should keep schools closed for the rest of this year to ensure the safety of our community. Please continue efforts to make sure everyone who needs to be tested can get tested, and have access to basic sanitation supplies and ppe. Thank you! Please protect our most vulnerable citizens: people with disabilities, people living in poverty, healthcare workers, and 24-Apr other working class people who are working on the front lines. Please do not rush into this. Please do not start school again for this school year. Bars and restaurants and hair stylists are hardly essential. Instead, prepare for and brace for the influx 24-Apr of tourists bringing the virus with them. I think phasing in reopening of bars, restaurants, and schools at this time is an ok thing to do. So far, the guidelines and recommendations from the Missoula County Health Dept. seem reasonable. I believe that these recommendations should stay as best practices and not all of these restrictions should be blanketed across the industry. For example, bar service in an orderly line can be a lot safer and easier to control/clean than table service. Establishments should be able to create their own safety plans that fit the space and service needs appropriately while following Health Department guidelines. With the reopening of bars and restaurants, the onus remains on individuals to keep our community healthy within these settings. Even with compliant establishments, individuals who are no conducting themselves in a safe or sanitary way (continuing to create social distance, utilizing appropriate hand washing), will certainly create health problems. While our community has suffered relatively little because of our early shelter-in-place restrictions. I believe Covid-19 will continue to spread without appropriate testing for more individuals that can track and quarantine those with the virus. More testing is in order before we will know assuredly if we are going to continue to remain healthy and haven't simply 24-Apr delayed the onset of the virus in Missoula. I hope that the county and city will delay opening schools until next fall. I think it's too difficult to protect the children, their families, and anyone they may meet with. It's an epidemic waiting to happen. As far as businesses go, I hope any businesses that can delay opening will do so to prevent the virus from spreading. There are many sanitation and distancing policies businesses should put in place if they are going to open. Those of us who want to stay out of businesses/restaurants, etc. can do so or wear a mask when attending those businesses.
